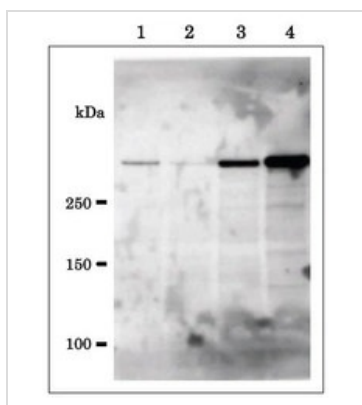

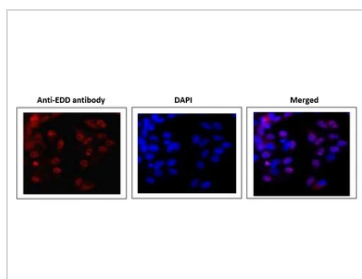
WB analysis of various samples using GTX00902 EDD antibody.
